decrease work-based funding rates (and fund the standard setting function using the reduction).

September 12: This consultation closes.

Decisions late 2024.

2025: legislative changes, and some funding changes.

1 Jan 2026: new structure implemented.

2. APPRENTICESHIP BOOST

from 1 Jan 2025:

First-year Apprentices only, first 12 months. \$500 per month.

Boost funding committed until June 2028









FINAL YEAR FREE

New govt has replaced "first year free" with "final year free".

Details still being confirmed but we expect apprentice fees from final <u>two</u> years will be refunded following completion.

They will only refund individuals, not employers.
